- 4. Pay a security deposit in full and sign a lease within 48 hours of application approval. Failure to do so can result in forfeiture of your application.
- 5 Upon acceptance, Be prepared to pay a non-refundable pet fee of \$200.00 when you sign the lease if the owner requires a fee at your desired rental.
- 6 Renter's Insurance: Please be aware that your personal property is not covered under the Landlord's insurance policy. You will need to arrange for your own insurance for personal items.
